

Terms and Conditions Governing OCBC StarHub Rebate on Google Home Promotion (“the Promotion”)

Promotion Period

1. The Promotion shall run from 20 April to 30 June 2018, both dates inclusive (“Promotion Period”).

Eligibility

2. You are eligible to take part in the Promotion ("Eligible Cardmembers") if:
 - (a) You are an existing OCBC Consumer Credit Cardholder and/or Debit Cardholder;
 - (b) Your OCBC Credit and Debit Card account(s) are in good standing with OCBC during the Promotion Period;
 - (c) You purchased a Google Home Mini or Google Home device at any of the StarHub Retail Outlets located in Singapore, of which the payment is made upfront with a OCBC Credit/Debit card in store at the StarHub Retail Outlet.
 - (d) You are also the StarHub service subscriber (same NRIC/Passport/FIN used) if you intend to purchase the Google Home device together with a StarHub service, of which the StarHub service is at least of a 12-month contract and excludes MaxMobile Plan

Promotion

3. During the Promotion Period, each Eligible Cardmember will receive S\$20 rebate (or discount off) every purchase of Google Home Mini or Google Home Device from a StarHub Retail Outlet.
4. The S\$20 rebate would be credited to your OCBC Card account by the subsequent month following the month that you made the purchase in.
5. The following cards are not eligible for the Promotion: OCBC Private Label Cards, OCBC Corporate Cards, BOS Voyage Corporate Cards and all OCBC Business Debit Cards.

6. Only Google Home Mini or Google Home devices purchased and payment made upfront at StarHub Retail Outlets (“Eligible Transactions”) would qualify for the Promotion. For the avoidance of doubt, the following transactions **would not qualify** as Eligible Transactions:

Transactions made via NETS, Cash on Instalment, Instalment Payment Plan, Internet Banking, AXS, SAM, Mobile Applications, Online, Mail or Telephone Order, Payment on delivery to StarHub would not qualify for the Promotion.

In the event of any ambiguity, OCBC retains the right to determine whether a particular transaction qualifies as an Eligible Transaction

General

7. OCBC has the right to end or withdraw the Promotion without giving you notice.
8. In the event an Eligible Transaction is cancelled or reversed (either in whole or in part) for any reason, we reserve the right to debit the corresponding value of the cash rebate from the card account that it was credited into.
9. If there is any difference between these terms and conditions and any brochure, marketing or promotional material relating to this Promotion, these terms and conditions will prevail
10. OCBC has the absolute discretion to amend, vary or change these terms and conditions without your consent or providing any notice to you.
11. OCBC shall not be responsible for the quality, merchantability or fitness for any aspect of the offer. Notwithstanding anything herein, OCBC shall not at any time be responsible or held liable for any defect or malfunction in any offer, and/or for any loss, injury, damage or harm suffered or incurred by or in connection with the use of any offer by any person.
12. OCBC's decision on all matters relating to privileges or terms and conditions will be final and binding on all participants.
13. These terms and conditions shall be governed by the laws of Singapore. A person who is not a party to any agreement governed by these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these terms and conditions.
